SUBJECT: Review and Possible Action Concerning Return

to In-Person Meetings Due to Repeal of Governor Emergency Executive Order

Suspending Brown Act Meeting Requirements

On June 11, 2021, the Governor issued Executive Order N-08-21 which repealed the Governor's prior COVID-19 Orders that suspended certain Brown Act requirements and permitted virtual/remote public meetings during the pandemic. N-08-21 gives public agencies until October 1 to transition back to in-person meetings now that the declared state of emergency has ended.

Discussion

On April 2, 2020, this Board established a temporary remote meeting place for the District's Board meetings based on the Governor's COVID-19 Orders, allowing Board members, staff and the public to participate in public meetings remotely. Since that time, the District has conducted all of its meetings virtually, via Zoom.

Many public agencies have expressed the need for the continuation of Brown Act remote meeting flexibility for various reasons, not the least of which is the surge in cases resulting from the Delta Variant. Currently, there are two avenues to pursue an extension of said flexibility, which include another gubernatorial executive order or the passage legislation such as <u>AB 361</u> (R. Rivas), which would grant local agencies approval to hold virtual meetings *only in the event of a declared local or state emergency that requires social distancing* without having to rely on an executive order. As of the date of this writing, AB 361 has been passed by the legislature and is presently before the Governor for signature, at which time it would become immediately effective.

Given the above described circumstances, at this time the District must return to its normal meeting practices as of October 1 in accordance with the Brown Act. Currently, such meeting practices must abide by current County Health Order No. C19-12 which mandates the wearing of masks in all indoor public settings.

Additionally, some agencies have adopted a hybrid meeting model by offering a virtual option for the public and/or staff/consultants concurrently with the

physical meeting location that would be accessible and interactive to those attending the meeting in-person.

WHEREAS, on March 4, 2020, Governor Newsom proclaimed a State of Emergency in California as a result of the threat of COVID-19. On March 19, 2020, the Governor issued Executive Order N-33-20 which, among other things, directed all California residents to immediately heed current State public health directives, including the March 19, 2020 directive of the State Public Health Officer to all State residents to stay home or at their place of residence, subject to certain exceptions; and

WHEREAS, on March 12, 2020 and March 18, 2020, Governor Newsom issued Executive Order N-25-20 and Executive Order N-29-20 ("Orders") mandating compliance with state and local public health measures to control the spread of COVID-19 and temporarily suspending portions of the Brown Act which address the conduct of public meetings; and

WHEREAS, pursuant to the Governor's Orders, the Board of Directors of the Montara Water and Sanitary District ("District"), a public agency, adopted Resolution No. 1669 on April 2, 2020, establishing a temporary virtual meeting location to conduct all of its regular and special meetings during the declared state of emergency in place of its regular meeting place in the Boardroom of the District's Administrative Offices located at 8888 Cabrillo Hwy, Montara; and

WHEREAS, on June 11, 2021, Governor Newsom issued Executive Order N-08-21 repealing the temporary suspension of portions of the Brown Act under the Orders as of October 1, 2021; and

WHEREAS, pursuant to Executive Order N-08-21, the Board of Directors desires to adopt this resolution to confirm and ratify its regular meeting place in the Boardroom of the District's Administrative Offices located at 8888 Cabrillo Hwy, Montara, as well as to allow for additional adjustments to the procedures for the conduct of meetings as deemed necessary, including offering an additional virtual/remote location to conduct its meetings at the same place and time as its regular location of meetings.

WHEREAS on March 16, 2020, as amended on March 31, 2019 and as may be further amended, the San Mateo County Health Officer issued a Shelter-in-Place Order directing all individuals to self-isolate in their places of residence and prohibiting non-essential public and private gatherings, in order to slow the spread of COVID-19; and
