Hi Erik,

I left a voice mail on your office machine today, hoping to give you a verbal heads up on the topic on hand. Please take a look at the string of emails below and the attached letter that I sent to Cabrillo Unified School District.

In short, we see two problems at Farallone School in Montara at this time. First, a public health and safety concern that may be unrelated to your concerns representing the California Coastal Commission. As state agency the MWSD is tasked to enforce state law protecting our community from cross connection health hazards at any premises connected to our system.

The second concern we have is the extensive remodel that is seemingly done with disregard to best management practices and without involvement of local agencies, except the fire department.

I am no expert in the implementation of the Coastal Act, but have the basic understanding that all developments within the coastal zone, including schools, are required to get a Coastal Development Permit (See attached document "CCC schools require CDP). It seems as if this step was missed. You may have an answer to this question ready and if you can please share your thoughts.

Lastly, If you would like to attend the meeting on Wednesday please let me know so I can ask to add you to the participant list.

Thanks again for meeting to discuss a private matter this morning at the Farallone School grounds.

While on site I realized the extensive nature of the work that is currently being done at the school. The work clearly involves water and sewer fixtures and therefore requires Montara Water and Sanitary District (MWSD(permits. MWSD requires permits for any work that involves water or sere fixtures regardless if fixtures are added or replaced. I am not aware of any permits issued by MWSD at this time and have placed a query with San Mateo County to find out the status of the permitting and county referral. If there is anything you can share to shed light on this mystery please do.

On a more pressing matter, I am very concerned about the ongoing significant remodel creating a cross contamination potential for the parts of school that are currently in use as well as for our entire community. A cross contamination potential is an immediate threat to public health and safety. At this time I am asking for an inspection with our staff tomorrow morning at 9:00 am. This would allow us to either confirm that the health and safety of our community and the children present at the school is protected, or advise on how to do so.

Please let me know if tomorrow at 9:00 am works for you.
