Nextdoor Page

Montara Water and Sanitary District (MWSD or District) is pleased to announce the creation and planned November 1 launch of the District's Nextdoor page.

In August, Nextdoor, a neighborhood-based social media network, announced a shift in policy to allow special districts to establish a formal 'Nextdoor for Public Agencies page' on the platform. Nextdoor's prior public agency policy did not recognize special districts, and as a special district, MWSD needed to ask a community resident to post District content. According to Nextdoor, 'more than 5,000 public agencies currently use Nextdoor. Many utilize the tool to share information with residents in specific neighborhoods. The tool may be effective in cases of community events, emergency alerts, and other messages targeting audiences based on geography.'

Staff have applied for and established a District page account on the platform, and are developing content as well as a posting policy, to ensure adequate administration, posting access, and protocols for District content. Posting is expected to highlight existing District outreach materials, such as the bi-monthly newsletter, as well as other items of community interest such as planned and emergency work, press releases, and videos (Virtual Tour, Strategic Discussions, etc.).

To maintain rapid response to community inquiries, District Nextdoor posts will direct questions and comments to the District's established email and phone numbers rather than through comments on District posts.

We look forward to our November 1 launch.

SUBJECT: Discuss Possible Changes to Director Meeting

Compensation

Director Slater-Carter requested a discussion about Directors meeting compensation.

Currently Directors receive \$75 per attended meeting. No direct comparison to other agencies has been prepared, however, the amount is the lowest of any Coastside government agency. The compensation for Directors has not been changed in at least 2 decades.

Health & Safety Code Section 6489 provides that compensation shall not exceed \$100 per day for each day's Board Member attendance at approved meetings or service, but that limitation may be exceeded under provisions of the Water Code.

Water Code Sections 20200 et seq. allow specified governing boards, (including Sanitary District Boards, per the cross-reference in Health & Safety Code Section 6489), to provide for compensation in excess of \$100 per day's attendance/service by an ordinance adopted following a public hearing and subject to referendum. Such the increase may not exceed 5% for each calendar year following the operative date of the last compensation adjustment. Additionally, such compensation shall not be paid for more than 10 days' attendance/service in any calendar month.

If a change in compensation is requested by the board, Legal Counsel can prepare an Ordinance for approval at a subsequent meeting.
